# Yuzhou Properties Ranks Eighth among Top 100 Companies in Xiamen

(15 August 2018, Hong Kong) **Yuzhou Properties Company Limited** ("**Yuzhou Properties**" or the "**Company**", together with its subsidiaries, the "**Group**"; stock code: **01628.HK**), a top 40 property developer in China, is pleased to announce that the Company has successfully ranked eighth among top 100 companies in Xiamen. On 13 August, the 2018 Top 100 Companies in Xiamen came to a successful conclusion. Yuzhou Group ranked eighth in the 2018 Top 100 Companies in Xiamen, and seventh in the 2018 Top 10 Service Companies in Xiamen. The evaluation was jointly hosted by the Xiamen Enterprises and Entrepreneurs Association, Xiamen Daily and Xiamen Media Group, with the assistance of the associations from different sectors.

### The evaluation reflects the prosperous development history of the companies in Xiamen

As a gala bearing witness to the development of the companies in Xiamen for the past 13 years, the Top 100 Companies in Xiamen genuinely reflects the development history of Xiamen companies, and summarizes the successful experience of company reform and development. There were 157 companies participating in the evaluation this year. The evaluation was conducted by the Xiamen Enterprises and Entrepreneurs Association by comparing the companies' sales revenue or operating revenue and other economic indicators provided by the companies or recommended by the sector according to the international practice and with reference to the evaluation rules of the Top 500 Chinese Companies. The companies listed on this year's 2018 Top 100 Companies in Xiamen are those with an operating revenue of RMB800 million or above.

The companies involved in the evaluation said that some new characteristics were observed from the ranking: first, structural change- over half of the companies on the list were private companies, which demonstrated the economic vitality of Xiamen; second, development quality improvement- high-tech companies grew rapidly, which demonstrated the development quality of Xiamen's economy; third, constant environmental optimization- stateowned companies continually improve the business environment of Xiamen through the efforts in the areas of service sector, ports and supply chains; fourth, green development in a



faster pace- a group of green companies which were willing to take on responsibility emerged as the Top 10 Green Companies. They will guide and encourage more companies to assume social responsibilities and adopt green growth.

## Yuzhou benefits from and supports urban development

Founded in Xiamen in 1994, Yuzhou Group has benefited from and supported urban development in its past twenty years of rapid development in Xiamen. Yuzhou started to implement the nationwide expansion strategy in 2004, listed in Hong Kong in 2009 and relocated the headquarters to Shanghai in 2016.

In its early development stage, Yuzhou Group focused on fostering a harmonious relationship between people and environment. Its first residential project was positioned as a green product. Yuzhou New Village made a foray into horizontal greening and was the first residential community approved by the Housing and Urban-Rural Construction Committee in Xiamen.



Founded in Xiamen in 1994, Yuzhou Group upholds an operating principle of "Building Cities with Heart, Building Homes with Love" to construct sophisticated residence. Yuzhou started

to implement the nationwide expansion strategy in 2004, listed in Hong Kong in 2009 and relocated the headquarters to Shanghai in 2016.

Following the implementation of the nationwide development strategy, Yuzhou successfully established footholds in Fuzhou and Shanghai and expanded into Hefei in 2006. Since 2015, it has ranked among top five companies for three years running. In 2010, Yuzhou expanded into the Bohai Rim and quickly became one of the top 10 companies shortly after entering Nanjing in 2014. While consolidating and improving its national presence, Yuzhou also entered the Greater Bay Area through M&A and cooperation. It acquired the Hong Kong Caine Road project in 2014, followed by the acquisition of a quality project in Huizhou through M&A in July 2017.



In 2017, the revenue of Yuzhou amounted to RMB21,700.67 million, up by 58.73% year-onyear; gross profit for the year amounted to RMB7,683.05 million, up by 54.93% year-on-year; core profit amounted to RMB2,923.99 million, up by 42.83% year-on-year; core earnings per share amounted to RMB0.74, up by 37.04%.

In 2018, Yuzhou speeded up the pace of expansion and entered seven major cities (Shenyang, Beijing, Zhengzhou, Xuzhou, Foshan, Haozhou, Chongqing) by various means such as acquisition of the assets of Coastal Greenland and bid invitation, auction or listing. It has expanded into 26 cities, as compared to 19 cities in 2017, which enables it to maintain a leading position in Haixi city cluster, consolidate its presence in the Yangtze River Delta and Beijing-Tianjin-Hubei hub, and solidify its foundation in the Bohai Rim and Central China city clusters. It regards the Greater Bay Area as a key strategic development region.



Adhering to the operating principle of "Building Cities with Heart, Building Homes with Love", Yuzhou will extend its footprints from Xiamen to other cities and support urban development to build more sophisticated residence.
