UNAUDITED OPERATING STATISTICS FOR MAY 2025

The board of directors (the “**Board**”) of Zhongliang Holdings Group Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce certain unaudited operating statistics of the Group for May 2025 as follows:

- From January to May 2025, the Group’s aggregated contracted sales (including contracted sales by joint ventures and associates) and contracted gross floor area (“**GFA**”) amounted to approximately RMB5.37 billion and 501,000 square metres (“**sq.m.**”), respectively. The Group’s contracted average selling price from January to May 2025 was approximately RMB10,700/sq.m.
- In May 2025, the Group’s contracted sales (including contracted sales by joint ventures and associates) amounted to approximately RMB1.02 billion with contracted GFA of approximately 103,000 sq.m. The Group’s contracted average selling price in May 2025 was approximately RMB9,900/sq.m.

The above-mentioned sales data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information. As such, the above data is provided for investors’ reference only.
