We will continue to reward our clients' loyalty by providing quality products and attentive services to their satisfaction, and persistently strive to thrive as a national brand in the international market."

Bauhinia Paints has three core businesses: household paints including inner and outer wall emulsion paints, water-based wood paints and solvent-based wood paints; industrial paints including paints for furniture, plastic products and heavy industries and anticorrosive paints; and architectural paints. Bauhinia Paints has always been upholding the brand positioning of "World-class Quality, China Focus" and has been one of the top four brands in China's household paints market. In future, more efforts in brand building will be made continuously so that, through advertising in different media and the launching of various creative marketing campaigns, a more distinctive brand image and a higher brand visibility can be realized.

Bauhinia Variegata Ink has achieved rapid growth in just over a decade aided by its dedicated professional operating philosophy. The Company has become a global leader in the ink manufacturing industry. Bauhinia Variegata Ink, the No. 1 ink manufacturer in China, is committed to sustainable development and steady growth. It took the lead to introduce an aromatic-free production plant and fully piped manufacturing mode in the industry. The production system is equipped with the nationally most advanced automatic controls and is linked to an Enterprise Resources Planning (ERP) system. Bauhinia Variegata Ink was among the first in the industry to be accredited for QC080000 certification for hazardous substance process management system, which can detect the content of different solvents, heavy metals and benzene. In 2010, it invested tens of millions of dollars to build a laboratory recognized by China National Accreditation Service for Conformity Assessment (CNAS) capable of conducting tests to meet international and domestic standards. Utilising its advanced hardware and human resources, the Company is set to develop new products incorporating green technology. Bauhinia Variegata Ink has recently launched a new gravure alcohol-based ink product series, which has been popularly received by the market. It plans to launch gravure water-based ink products, water-based offset ink products and environmentally-friendly silk screen inks for glass in the coming two years. The Company's offset printing ink products have obtained the "China Environmental Labelling Certification" and garnered the "Green Technology Award" from the Green Promotion Campaign for the printing industry in China.
